GENERAL RULES:

1. Will follow AHCA Show General Rules & Regulations.
2. Premise ID required.
3. CVI within 30 days of show.
4. See General Rules and rules applicable to livestock for additional information.
5. Enter cattle by Division.
6. All cattle will be shown and stalled on halter.
7. All bulls 12 month or older must be shown with nose leads.
8. All animals must be registered and in good standing with AHCA.

JUNIOR & SHOWMANSHIP RULES:

1. Participant must be a junior member of AHCA (8 years and older, under 8 no membership required).
2. The animal must be a heifer or steer born after January 1, 2021, and the animal must be registered with AHCA in the junior's name, parent's name, or legal guardian's name (except showmanship).
3. Bulls under one year of age, steers and heifers may be shown in showmanship.

ROE RULES:

AHCA Rules for ROE Sanctioned Shows

Owners must be members in good standing of the American Highland Cattle Association or Canadian Highland Cattle Society. All animals must be owned by the owner and breeding stock registered with the American Highland Cattle Association or Canadian Highland Cattle Society.

All shows will conform with IAFE Code of Show Ring Ethics and show rules (see www.highlandcattleusa). Registration papers must be presented to show officials or AHCA representatives upon request. Tattoos must be legible and correspond to registration papers.

Use of hormones or steroids in animals exhibited is prohibited.

Fullblood breeding cattle may not be dehorned.

A calf in the cow/calf class must be the cow's natural calf, still nursing and a maximum of 250 days old. Both the cow and calf must be registered fullblood Highland cattle.

All bulls 12 months or older must be shown with a nose ring or nose lead. Note: We recommend that bulls be experienced with nose ring or nose lead prior to showing the animal. Registered and unregistered market animals (both pure and crossbred) and registered Sovereign heifers, will be included for the number of animals in a point show.

Only registered pure and crossbred market animals and registered Sovereign heifers will count toward the Premier Breeder and Exhibitor awards at all ROE shows.

Animals in group classes Get-of-Sire, Produce-of-Dam and Breeders Herd must be registered fullblood Highland cattle.

Jackpot classes will be left to the discretion of each individual show to structure as they see fit (fullblood/Sovereign/crossbred).

Show organizers need to use the Herdbook Search on AHCA's website to verify all animal names/numbers are correct in show catalogs before printing.

Also, all owners should be verified as current AHCA members and cattle entered on their entry forms are in their ownership.

A junior's age is determined as their age on January 1 st and can show in junior classes through age 21.

Special consideration will be extended at all shows for persons with developmental disabilities to show in the junior show through age 26.

ROE may result in a tie in which all recipients will be recognized.

Junior exhibitors showing in the open show, points for Premier Breeder and Premier Exhibitor will be awarded to the family farm.

In the event of joint ownership of an animal, Premier Exhibitor/Breeder points will be given to the farm that entered/exhibited the animal, unless specified prior to the start of the show.
